- 3. EMPLOYER shall timely file all future wage and premium reports and shall timely pay all taxes thereby required;
- 4. A TAX LIEN, if not already in place, will be filed immediately upon execution of this Agreement.
- 5. Any debt submitted to the Treasury Offset Program (TOP) prior to the execution of this agreement will remain subject to offset by the United States Treasury.
- 6. By executing this pay agreement, and delivery of the same to the DEPARTMENT, the EMPLOYER hereby submits the proposal delineated herein to the DEPARTMENT for approval;
- 7. That approval by the DEPARTMENT shall in no way constitutes a compromise or waiver of any of its rights at law or equity; but on approval, it is mutually agreed that the DEPARTMENT will not initiate legal action to enforce collection of the above stated tax indebtedness so long as the EMPLOYER strictly complies with all terms of this agreement; but if EMPLOYER fails to file any future quarterly wage and premium report, and/or to pay the appropriate taxes thereon before the expiration of the due date, then it is understood that legal action may be filed by the DEPARTMENT without further notice to the EMPLOYER.
- 8. In addition, the EMPLOYER'S failure to strictly comply with each and every provision of this agreement shall constitute a breach hereto; and all unpaid premiums and interest shall be accelerated and immediately due in full.
